There is an additional charge for the final exam which is priced at 117.00 USD and is paid directly to NHA (National Health Care Association) website on the day of the test.

Tuition and fee charges are subject to change at the school's discretion. Any tuition or fee increases will become effective for the term following student notification of the increase. The cost of the course does include the National Exam Fees.

REQUIREMENTS: You must have a high school diploma or GED certificate prior to the application deadline and that you have no felony conviction in your past.

CLASS CANCELLATION POLICIES: A+ Phlebotomy LLC has the right to cancel a class due to insufficient enrollment. Students will be notified if a class, for which they have enrolled, is cancelled. If a student has not been notified, he/she may assume the class will be held.

ATTENDANCE: Each student is expected to attend every class session. In the case of absence, the student should immediately notify the instructor. Every student assumes the responsibility of completing assigned work whether present or not.

TERMINATION: If a student persistently fails to stay within the bounds of acceptable behavior, or does not meet tuition payment schedules, he/she may be terminated from the program.

Cancellation and Settlement Policy

This enrollment agreement may be cancelled within five calendar days after the date of signing provided that the school is notified of the cancellation in writing. If such cancellation is made, the school will promptly refund in full all tuition and fees paid pursuant to the enrollment agreement and the refund shall be made no later than thirty days after cancellation. This provision shall not apply if the student has already started academic classes.

Refund Policy

If the student is not accepted into the training program, all monies paid by the student shall be refunded. Refunds for books, supplies, and consumable fees shall be made in accordance with the policies of A+ Phlebotomy LLC. There is one (1) academic term for this program that is 24 clock hours in length.

- (1) A student who withdraws before the first class and after the 5-day cancellation period shall be obligated for the registration fee.
- (2) A student who starts a class and withdraws before the academic term is 15% completed will be obligated for 25% of the tuition and refundable fees, plus the registration fee.
- (3) A student who starts class and withdraws after the academic term is 15% but before the academic term is 25% completed will be obligated for 50% of the tuition and refundable fees plus the registration fee.
- (4) A student who starts class and withdraws after the academic term is 25% complete but before the academic term is 40% completed will be obligated for 75% of the tuition and refundable fees plus the registration fee.
- (5) A student who starts class and withdraws after the academic term is 40% completed will not be entitled to a refund of the tuition and fees.

A+ Phlebotomy LLC shall make the appropriate refund within thirty days of the date the school is able to determine that a student has withdrawn or has been terminated from a program. Refunds shall be based upon the last date of a student's attendance or participation in an academic school activity. The student's account is to be paid in full by the last class session. Any balance remaining after 30 days is subject to all legal remedies, including use of a collection agent.

Complaint or Grievance Procedure

All student complaints should first be directed to the school personnel involved. If no resolution is forthcoming, a written complaint shall be submitted to the director of the school.
